1. Bansgadhi Municipality Office invites sealed bids or electronic bids from eligible bidders for the upgrading of East-West Highway Bansgadhi Chowk-Laxmanpur-Newada-Amohiya Road (Phase I) (Ch: 0+000 to 0+250) under national competitive bidding procedures.
2. Eligible bidders may obtain further information and inspect the bidding documents at the office of the Bansgadhi Municipality or may visit PPMO's website www.bolpatra.gov.np.
3. Bidding documents may be purchased from the above office from 2073-09-17 to 2073-10-17 in office time, by eligible Bidders on the submission of a written application accompanied by a letter of Authority from the Principal/Manufacturer to the address above, along with the copy of company/ Firm registration certificate, PAN and VAT registration certificate, Tax clearance certificate of fiscal year 2072/73 and upon payment of a non-refundable fee of NRs. 3,000/- in cash for a set of bidding documents or in form of bank receipt for fee deposited in Rastriya Banijya Bank, Gulariya Branch, Bardiya, revenue account No 4140304034302 on behalf of Bansgadhi Municipality Office, Bansgadhi, Bardiya.

Bidder who choose to submit their bid electronically may purchase the hard copy of the bidding documents as mentioned above or may download the bidding documents for e- submission from PPMO's website www.bolpatra.gov.np. Bidders submitting their bid electronically should deposit the cost of bid document in the above revenue account and the scanned copy (PDF Format) of the bank deposit voucher shall be uploaded by the bidders at the time of electronically submission of the bids.

4. Sealed or electronic bids must be submitted to the Bansgadhi Municipality office, Bardiya by hand or courier or through PPMO website www.bolpatra.gov.np on or before 12:00 Noon on 2073-10-18. Documents received after this deadline shall not be accepted.
5. Pre-Bid meeting shall be held at the Bansgadhi Municipality Office at 2:00 P.M 2073-10-07.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 2:00 pm on 2073/10/18 at the Bansgadhi Municipality Office, Bardaiy. Bids must be valid for a period of 90 (Ninety) days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in pdf format in case of e-bid, amounting to a minimum of NRs. 2,50,000.00 which shall be valid for 30 days beyond the validity period of the bid. 7. If the last date of purchasing, submission and opening falls on a government holiday then the next working day shall be considered the last day. In such a case the bid validity and bid security validity shall be recognized with effect from the original bid submission deadline.
8. Bids should comply in all respects with the Instruction to Bidder included in the Bid Document. Non compliance with this instruction shall result in disqualification.
9. Bidders who choose to submit the bid by E-bidding system must submit the original copies(Hard copy) of mandatory documents to Bansgadhi Municipality Office Bardiya within the five days of last date of bid submission. No submission of the hard copy by the bidders within the specified time shall be considered as non responsive and may cause forfeiture of bid security.
10. The employer reserves the right to accept or reject, wholly or partly any or all the bids without assigning reason, whatsoever.
11. Bidders are advised to visit the site and assess the actual site condition before submitting their bid.
